#### Officers

#### Responsibilities

- Meet at least once during each long semester.
- Advise the administrative directors of housing and auxiliary services on policies and operations of the residence halls, specifically in the areas of student services and programs.
- Assist the Director of Housing in implementing approved services and programs.

- Establish subcommittees to study and make recommendations on issues and concerns pertaining to residence hall programs and services.
- Provide assistance in the selection of residence hall head residents by serving on selection committees.

#### Composition and Terms of Membership

- 2 student residents from each residence hall appointed by the Student Government Association President (voting)
- 1 student representing the University Program Board appointed by the Student Government Association President (voting)
- 1 student representing the Student Government Association appointed by the Student Government Association President (voting)
- 2 faculty members recommended by the Faculty Senate (voting)
- Director of Housing (ex-officio, non-voting)
- Director of Auxiliary Services (ex-officio, non-voting)
- Chief of University Police or designee (ex-officio, non-voting)
- Director of Physical Plant or designee (ex-officio, non-voting)

Each ex-officio member will chair a subcommittee of the Residence Hall Advisory Committee that deals with his or her area of expertise. At least 2 student committee members shall serve on each subcommittee.

Student members are appointed to 1-year terms (students may be re-appointed to consecutive terms). Faculty members are appointed to 3-year terms.

#### Reporting

The Residence Hall Advisory Committee reports to the Vice President for Enrollment and Student Services.
